Dear Prime Minister Johnson,

as I have done so often before, I am looking for contact with you as well as with the other presidents of the Allied occupation forces of the German Reich. You are well aware that my colleagues and I are enthusiastic fighters for the restoration of the German Empire, just like the other 43 known groups within the territory of the Reich. However, I dare say that our proposals are the most far-reaching. I have sent both you and the other members of the Allied Control Council a request for accreditation, a request for recognition as head of an interim government and finally a call for help for the liberation of the German peoples. All this correspondence remained officially unanswered. In our efforts to make all this correspondence as well researched as possible and thus legally correct, we have made a serious mistake. No, I am not so arrogant as to not admit this mistake. Unfortunately, I only noticed this mistake when I read at least parts of the plan for the intended reform of the Constitution of the Russian Federation. In this reform the Russian people will decide that the Russian Federation is the legal successor of the Soviet Union. And only here I noticed that our efforts to restore the German Empire are the second step before the first. We have indeed completely ignored the fact that only the Second World War must be completed in order to enter into negotiations about the actual reactivation of the German Empire. We, or rather I, have emphasized in all our letters that we refer to the international law defined borders of 31.12.1937. But these are the borders which were defined in the Yalta Conference and therefore have no connection with the German Empire. It is about the borders of the German Empire under the leadership of Adolf Hitler.

Consequently, both the accreditation as well as all other letters to you and the members of the Allied Control Council were not in the correct factual context and could not be answered by you or the members of the Allied Control Council. I ask you in particular, Boris Johnson, to forgive this gross error, which should not have happened. I also do not want to quote the fact that we are only human and therefore prone to mistakes as an excuse. It should have already become apparent during the research that we have simply suppressed the most important things and did not include them in our considerations. So in order to achieve our goal, the reactivation of the German Empire, I will submit a new application for accreditation. Here with the premise to take over the representation of the last government of the Reich under Admiral Dönitz in order to then work out the possibility to achieve a final peace treaty to end the Second World War. Since, according to the surrender document of 5 May 1945, English version (copy enclosed) and the version of 8 May 1945 written in Russian, which only lists the signatures (copy enclosed), only the armed German troops but not the presently acting Reich government capitulated, it is absolutely legitimate to apply for the continuation of the government business within the framework of an accreditation as provisional administrator on behalf of the Allied Control Council.

It is, in my view, time to use fresh and politically unencumbered forces to rebuild after the Corona crisis. The established "politicians" cannot be used for the time after that simply because of their previous burden, otherwise nothing would be able to develop in the heart of Europe.

Allow me to make a few thoughts about the areas of the German Reich currently under foreign administration. Of course, when concluding a peace treaty, the demarcation of the borders according to the Yalta Protocol must be taken into account. It is not our aim to expel the people living in the occupied territories. My colleagues and I have unanimously decided to create Autonomous Republics from the occupied territories. These are undeniably part of the Reich and Reich law will also undeniably apply, but we intend to

offer a peaceful future for all the peoples involved, a future that will be free from the burden of history.

The generations that exist today have nothing to do with the last war and it is absolutely useless to insist by hook or crook on existing borders and lose sight of humanity. It is time to create a peaceful coexistence.

I remain in the hope that my remarks will be heard and that the submitted accreditation will meet with your approval.
