

Application for accreditation as

Provisional administrator of the German Reich government for the continuation of the affairs of government of the Dönitz government with the approval of the Supreme Allied Control Council in the territory of the occupied German Reich.

Dear Prime Minister Boris Johnson,

on the basis of the actual legal situation in the German Reich, after having received the instructions and approval of the Supreme Allied Control Council, I hereby apply for Frank Kahn, residing at An der Beeke 3, D-37170 Uslar-Schlarpe, Federal Republic of Germany in the German Reich, to have the letter of accreditation shown below approved by you by signature and seal as a permanent member of the Supreme Allied Control Council.

The following is therefore requested for approval:

Frank Kahn, as the Provisional Administrator of the German Reich Government, is under the special protection of the Supreme Allied Control Council, and on the basis of the S.H.A.E.F.- SMAD legislation, in connection with all contracts and agreements concluded, no person of the local "FRG bodies" may be impaired in his work at any time.

Frank Kahn will be placed before the so called "FRG Government" in the rank of a Supreme Commander-in-Chief in the service of the Supreme Allied Control Council. He is authorized to conduct all official, service and/or governmental affairs in such a manner that members of the incumbent, so-called "Government", as well as all other heads of administrative units up to the lowest level of administration within the construct known as the "United Economic Area" are replaced by qualified employees and/or a new, provisional government is established with the approval of the Supreme Allied Control Council.

Frank Kahn shall therefore have unrestricted access to everything and to everyone, here in detail without exception to all buildings of the so-called FRG Government, FRG Justice and all other associated offices down to the lowest level of the associated administrative levels.

Frank Kahn has through the S.H.A.E.F.- SMAD legislator access to all banks and financial institutions and their own accounts, and these without any limitation for the purpose of averting
of disadvantages against the occupied German Reich and its native population, and in the case of suspected violations, may also issue orders. At his request, all documents must be submitted to him for verification.

Frank Kahn is used instead of or also within the scope of the deployment of military units in order to avoid overtaxing the local population under any circumstances (outbreak of tumultuous panic).

Frank Kahn is generally to be given every conceivable support by the so-called still existing "BRD organs". Should Frank Kahn gain the impression that subversive cooperation is being carried out, he will immediately inform the accreditation body to ensure that it can counteract this by taking immediate action.

On the basis of the still valid, sole German constitution of 1871 as well as the only true valid German legal norms and/or a foreign legal system, Frank Kahn is expressly entitled to carry out legal transactions in the sense of an official and governmental activity, without the need for a separate consent.

Frank Kahn is entitled and at the same time authorized to use all sovereign institutions and legal remedies. In order to ensure the smooth conduct of his authorization to carry out official and / or governmental affairs, all institutions under sovereign law are obliged and required to provide Frank Kahn in the service of the Supreme Allied Control Council with unrestricted administrative assistance.

The currently so-called rulers are, on the basis of the current legal situation, purely private individuals and thus do not belong to any diplomatic corps (*persona non grata*).

This document of the Supreme Allied Control Council is valid for the occupied German territory as a whole.

This document only loses its validity when it is expressly revoked in writing by the issuing, permanent member of the Supreme Allied Control Council.

This application for accreditation is approved in accordance with the Regulations, Treaties and S.H.A.E.F.- SMAD Acts listed below by the Prime Minister of the United Kingdom and Northern Ireland and permanent member of the Supreme Allied Control Council, Boris Johnson.
